The Company is classified as Non-deposit taking systemically important NBFCs (NBFCs-NDSI).
- 2. The financial results for the quarter ended September 30, 2022 have been reviewed by the Audit Committee and approved by the Board of Directors at its meeting held on November 14, 2022 and a limited review of the same has been carried out by the statutory auditors.
