Further to this, the Company has ceased to carry-on NBFC business w.e.f. December 20, 2024, and the Transferee Company has commenced NBFC business w.e.f. December 21, 2024.

Given this, the ALM Statement filed with Reserve Bank of India for the month of December 2024 has been filed in the name of the Company for the period from December 01, 2024 to December 20, 2024 and for the period from December 21, 2024 to December 31, 2024, the same has been filed in the name of the Transferee Company.

The ALM Statement filed by both the Company and the Transferee Company (Samunnati Finance Private Limited) are attached.
